Attachments	<b>Pedigree.</b> Attach an 8.5" x 11" photocopy of a three-generation pedigree issued by an acceptable domestic or foreign registry. 	<b>Note:</b> If you do not have a three-generation pedigree issued by an acceptable foreign registry, you may submit export papers or any supporting documentation identifying the breed, sire, dam, and your ownership.
	<b>Photographs.</b> Attach two (2) 3" x 5" close-up color photographs of the dog in a standing position: one front view; one side view. Print the dog's name and registration number on the back of each photograph.
